hereditaments and real estate whatsoever and where soever to them their
heirs and assigns forever to be divided among them share and share alike

Item I give and bequeath unto my children above named all the remain-
-ing and residue of my personal estate after the payment of my just
debts and funeral expenses in equal portions share and share alike

Item In case any of my said children should die under the age of twenty
one years and without lawful issue then my will is that the portion herein
divided or bequeathed to such child or children shall be equally divided
between the remainder of my said children in equal portions share and
share alike

Lastly I hereby appoint my trusty and well beloved friends David Smith
and Hezekiah Shaw Executors of this my last will and testament and
guardians to my said children (excepting Ruth Ann) during their minor-
-ity
