Item I give and bequeath unto my son Joseph Scull Junr two acres of land adjoining his lot on the southeast side of the road Beginning at his East corner and running of the same course of his East line into the field a sufficient distance to make the two acres by running a parallel line with road up to Andrew Sculls line

Item I now give unto my children share and share alike equal that is to say Andrew Scull the one fifth part of all my personal and real estate after the fore named distribution is taking out Joseph Scull Junr the one fifth part Alice C Scull the one fifth part Susanna Chapman the one fifth part Martin Vanburan Scull and Abel Scull my two grand sons together the one fifth part share and share alike between the two I also nominate constitute & appoint my Executors herein after named Guardians of my two grand sons namely Martin Vanburan Scull and Abel Scull untill they shall arrive to the age of twenty one years Lastly I hereby appoint my son Joseph Scull Junr and David B Somers Executors of this my last will and testament In Witness Testimony whereof I have hereunto set my hand and seal this eleventh day of April A.D. one thousand eight hundred and fifty three

Fourth I ordain and appoint my beloved wife Elmira A Adams as executrix of this my last Will and Testament
