I devise all my real estate to my four sons namely David Lee Henry Lee, Phillip Lee, and Samuel Lee, equally share and share alike,

I item at the marriage or death of my wife as afore stated I give and bequeath the balance of my personal property unto my six daughters namely Ann Lee wife of Isreal Lee, Rachel Steelman wife of Townsend Steelman late Lee, Louisa Lee, Elizabeth Lee, Ann Lee, and Josephine Lee share and share alike,

And if any one of my sons above named shall decease without leaving lawful heirs than it is my will and I do order his share to be equally divided between the balance of my sons living

Lastly I hereby appoint my beloved wife Mary Lee and my son David Lee Executrix and Executor of this my last will and testament In Witness whereof I have hereunto set my hand and seal this twenty first day of November A.D. one thousand eight hundred and fifty nine 1859
