

the term of her natural life.

It is my will that after my daughter's death my entire estate, real, personal and mixed shall be equally divided among my grandchildren, share and share alike when they reach the age of twenty-one years, provided my daughter's death occurs before they reach this age. In any event the estate is not to be divided until after the death of my said daughter. In the event of the death of any of my grandchildren, leaving issue, then I direct that the portion due such deceased grand-child or children shall be equally divided among the issue of such deceased grandchild or children. Should any grand-child or grand-children die without issue then the portion due such deceased grand child or grand-children shall be equally divided among the survivor or survivors of my grandchildren share and share alike.

Lastly, I nominate and appoint my daughter Margaret R. Baldenau and the Pennsylvania Company for Insurances on Lives and Granting Annuities, 517 Chestnut Street, Philadelphia executors of this my last will and testament.
