We do assign and set off to Somers Scull the lots marked and numbered 4 on the aforesaid Map, the first lot being begins at the beginning corner of lot No. 1 and run thence North fifty nine degrees West forty four chains and nine links to a corner of No. 2, in the line of the heirs of John Somers deceased, then South thirty degrees and forty five minutes West two chains and two links in a line of the same to a corner of No. 5, then South fifty nine degrees East forty four chains in a line of lot No. 5 to the fourth corner of lot No. 1, then North thirty five degrees and thirty five minutes East two chains and eleven and two thirds of a link, in a line of lot No. 1, to the place of beginning, containing nine acres and twenty four hundredths of an acre.
