Hannah & Smith

Beginning at a stone in the middle of the Road leading from Estelville to Mays Landing and in the line of Elias Smith and running from thence (1)st in the middle of said Road South thirteen degrees and forty five East four chains and sixteen links to a stone corner of lands of Richard Smith (2)nd in his line South fifty nine degrees and forty five minutes West seventeen chains and ninety links to a stone corner of number 5 or a lot set off to Amelia Smith thence (3)rd along her line North fifteen degrees West four chains and eleven links to a stone corner of No 34 a line of a lot set off to Hannah & Fannie thence (4)th along her line North fifty nine degrees and forty five minutes East eighteen chains and twenty five links to the Beginning containing by estimation seven acres and twenty three hundredths be the same more or less and the lower lot of Meadow so called lying on Gibsons creek adjoining Meadow of Jesse Jones and others butted and bounded as follows

Beginning by a stake by the North east side of Gibsons Creek and in the line with ditch of Jesse Jones and running from thence (1)st along said corner line ditch North seventy six degrees East nine chains and twelve links to a stake corner of Meadow of the heirs of Richard Weeks deceased thence (2)nd along their line North three degrees West three chains and ninety links to a stake corner of said heirs thence (3)rd along a line ditch South eighty four degrees West two chains to the head of a small line creek the general courses are (4)th South ^{thirty eight} degrees West four chains and twenty five links (5)th South sixty one degrees and thirty minutes West two chains (6)th South twenty degrees West two chains to Gibsons Creek thence (7)th up said Gibsons Creek and binding the same North eleven degrees and fifteen minutes West eight chains and twenty five links to the Beginning containing by estimation four acres and forty hundredths be the same more or less and lot No 5 of the Shaw place so called and butted and bounded as follows

Beginning at a stone in the middle of the Road leading from Estelville to Mays Landing and corner of lot No 182 or the lot set off to Priscilla Smith and running from thence (1)st along the middle of said Road North thirty four degrees and forty five minutes East six chains and twelve links to a stone in said Road corner of No 6 or lot set off to John Smith thence (2)nd in the line of said John & Smith or No 8 East eight chains and thirty links to a stone corner of No 4 or lot set off to Phebe J Smith thence (3)rd in said line of thence (3)rd in said line Number 4 South five chains to a stone corner of Number 8 or lot set off to Amelia Smith thence (4)th along the line of No 3, 2, 1. or Amelia Smith and Priscilla Smith West eleven chains and eighty links to the Beginning containing by estimation five acres and twenty five hundredths be the same more or less

Secondly the metes and bounds of the share and proportion of Hannah & Smith are as follows which we have set off and assigned to her as her share just proportion of said estate No 1 of her share is that part of the homestead plantations of said deceased on the map heretofore annexed Numbered 3 and is butted and bounded as follows Beginning at a stone in the middle of the Public Road leading from Estelville to Mays Landing and corner of No 283 or the lot set off to Burroughs & Smith and running from thence (1)st along said road South thirteen degrees and forty five minutes East four chains and sixteen links to a stone corner of No 4 or a lot set off to Eliza & Smith thence (2)nd in her line South fifty nine degrees and forty five minutes West eighteen chains and twenty five links to her corner a stone in the line of No 5 or a lot set off to Amelia Smith thence (3)rd in her line North nineteen degrees West four chains and eleven links to a stone corner of No 286 thence (4)th along the line of Number 2 or a lot set off to Burroughs & Smith North fifty nine degrees and forty five minutes East eighteen chains and fifty five links to the beginning containing by estimation seven acres and twenty eight hundredths be the same more or less

No 2 of this proportion is a lot of Meadow adjoining the heirs of Richard Weeks deceased lying on Great Egg Harbour River and is butted and bounded as follows Beginning at a stone in the middle of the Road leading from Estelville to Mays Landing and running from thence (1)st along the middle of said Road North thirty four degrees and forty five minutes East six chains and twelve links to a stone in said Road corner of No 6 or lot set off to John Smith thence (2)nd in the line of said John & Smith or No 8 East eight chains and thirty links to a stone corner of No 4 or lot set off to Phebe J Smith thence (3)rd in said line of thence (3)rd in said line Number 4 South five chains to a stone corner of Number 8 or lot set off to Amelia Smith thence (4)th along the line of No 3, 2, 1. or Amelia Smith and Priscilla Smith West eleven chains and eighty links to the Beginning containing by estimation five acres and twenty five hundredths be the same more or less

South westerly side of Great Egg Harbour River two chains and fifty links above the mouth of the upper going through ditch and running from thence (1)st along his line South eighty eight degrees West seventeen chains and twenty five links to a stake corner of the meadow of the heirs of Rich and Weeks thence (2)nd in their line North five chains and twenty five links to a stake corner of Richard Smith thence (3)rd in his line North eighty eight degrees East sixteen chains and fifty links to his corner by said River thence (4)th down said River binding the same to the beginning containing by estimation eight and a half acres

Number 3 of said apportionment is the store house of said deceased. Thirdly unto Amelia Smith we have set off and assigned lot on said map heretofore annexed being a part of the plantation of said deceased whereon he dwelt and numbered 5 on said map and is butted and bounded as follows Beginning at a stone in the line of Richard Smith and corner of No 435 or the lot assigned and set off to Eliza & Smith and running from thence (1)st along the line of said Richard Smith South fifty nine degrees and forty five minutes West fourteen chains and forty three links to his corner a stone by the Road leading from Estelville to Mays Landing thence (2)nd along said Road North four degrees and thirty minutes West eight chains and eighty seven links to a stone corner of Number 6 or a lot set off to Phebe J Smith thence (3)rd along her line North fifty nine degrees and forty five minutes East twelve chains and ten links to a stone corner of Number 2, 5, 8, 6 thence (4)th in the line of Number 3, 4 or line of Hannah & Eliza & Smith South nineteen degrees East eight chains and twenty two links to the beginning containing by estimation ten acres and twenty hundredths be the same more or less

Number 2 of said assignment is a part of the Shaw place and the map of the same is numbered 3 and is butted and bounded as follows Beginning at a stone in the Road leading from the main road to the meadow and corner of a lot of land in the occupancy of Aaron Shaw and running from thence (1)st along said road South eighty one degrees and fifteen minutes West three chains and forty links to a stone corner of Number 182 or a lot set off to Priscilla Smith thence (2)nd in her line North seven chains and thirty six links to a stone corner of No 1, 2, 3 in Sylvia & Smiths line thence (3)rd in her line East six chains and eighty links to a stone her corner in the line of Number 4 or a lot set off to Phebe J Smith thence (4)th in her line South three chains and twenty five links to a stone corner of said Aaron Shaws lot thence (5)th in his line South eighty one degrees and fifteen minutes West three chains and fifty links to a stone his corner thence (6)th along his line South three chains to the beginning containing by estimation three acres and sixty two hundredths be the same more or less

Number three of this allotment is a meadow lying on the south River and is butted and bounded as follows Beginning at a stake by the north easterly side of South River and corner of Number 182 or a lot of Meadow set off to Priscilla Smith and running from thence (1)st up said South River North thirty five degrees and thirty minutes West four chains and thirty links thence (2)nd North forty eight degrees West six chains and twenty five links thence (3)rd North twelve degrees West two chains to a stake corner of Number 2, 8, 3 or a lot set off to John Smith thence (4)th in his line North eighty three degrees and forty five minutes East fourteen chains to the line ditch corner of Meadow of Enoch Doughty and the heirs of William Weeks deceased thence (5)th along said line ditch South five degrees and thirty minutes West five chains and eighteen links to a stake corner of Number 1 or lot set off to Priscilla Smith in the said second line thence (6)th along the line of Number 1 South forty degrees West nine chains and fifty links to the beginning containing by estimation eight acres and twenty hundredths be the same more or less

Number 4 of this allotment is a lot of Meadow lying on the south River and is butted and bounded as follows Beginning at a stone in the middle of the Road leading from Estelville to Mays Landing and running from thence (1)st along the middle of said Road North thirty four degrees and forty five minutes East six chains and twelve links to a stone in said Road corner of No 6 or lot set off to John Smith thence (2)nd in the line of said John & Smith or No 8 East eight chains and thirty links to a stone corner of No 4 or lot set off to Phebe J Smith thence (3)rd in said line of thence (3)rd in said line Number 4 South five chains to a stone corner of Number 8 or lot set off to Amelia Smith thence (4)th along the line of No 3, 2, 1. or Amelia Smith and Priscilla Smith West eleven chains and eighty links to the Beginning containing by estimation five acres and twenty five hundredths be the same more or less
