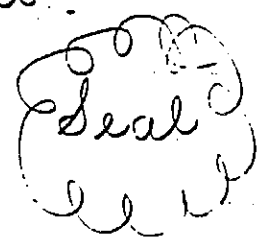
In the Matter of the probate of the last will and testament of Samuel Somers deceased. Order For Probate.
