

properties shall be sold until the expiration of five years from my death at which time this limitation and restriction shall cease and determine and become void.

Eighth: All the rest residue and remainder of my Estate real personal and mixed of whatever the same may consist and wheresoever situate I give devise and bequeath in equal shares share and share alike unto my said two children Willard S. Post and Irene Post their heirs and assigns absolutely. It is my wish though I do not so direct that my said children reserve the best pieces of furniture and pictures and such other things as cannot well be replaced for their own use and that the property at Wayne Pa be sold as my said two children may agree but not at a sacrifice.

Ninth: In the event that either of my said two children Willard and Irene should be dissatisfied with the provisions of this my Will and should contest the same it is my Will and I hereby direct that such contestant shall thereupon be totally disinherited and receive no part or share of my Estate whatever and the bequests devised and provisions made in this my Will in favor of such contestant shall thereupon be revoked and the same shall go to and inure to the benefit of the noncontesting.

Largely I nominate constitute and appoint my said two children Willard S. Post and Irene Post and the survivor of them the Executors of this my last Will and Testament.
