In the Matter of the probate of the last will and testament of Edw. S. Collins deceased. } Order For Probate.

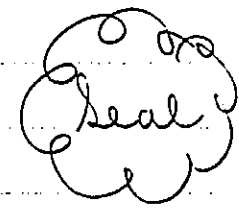
