I give and bequeath unto my friend John F. Reardon the sum of One thousand dollars absolutely.

I direct that my Executors hereinafter named shall expend the sum of ten thousand dollars in having celebrated one hundred Masses, each for the happy repose of the souls of my father, mother and each of my brothers and sisters.

I give and bequeath unto my cousin Timothy Doris the sum of five hundred dollars.

I give and bequeath unto my cousin Ellen Chapman the sum of One thousand dollars.

I give and bequeath unto my cousin Sarah A. McGrady the sum of Five hundred dollars.

I give and bequeath unto my friend Bridget O'heill the sum of Two hundred dollars.

I direct that the sum of One thousand dollars shall be expended in having Masses celebrated for the happy repose of my soul.

I direct that the sum of Five hundred dollars be given towards building a school in connection with the Star of the Sea Catholic Church at Atlantic City.

I direct that the interest or income arising from the sum of Ten thousand dollars shall be given to assist the Catholic Missionaries in instructing the Indians of the United States in the principles and doctrines of the Roman Catholic Church.

I direct that the interest or income arising from the sum of Fifteen thousand dollars shall be given to assist the Catholic Missionaries in instructing the Negroes of the United States in the principles and doctrines of the Roman Catholic Church.

All the rest residue and remainder of my estate, I give, devise and bequeath to my sister Catharine Bloomer.

I hereby nominate constitute and appoint my sister Catharine Bloomer, and my friends Bernard Lord and John F. Reardon or the survivor of them the Executors of this my last will and testament and hereby authorize, direct and empower, them to sell at public or private sale for such price or prices as to them may seem best any and all of my real estate without any liability on the part of the purchaser or purchasers thereof to see to the application of the purchase money or moneys.
