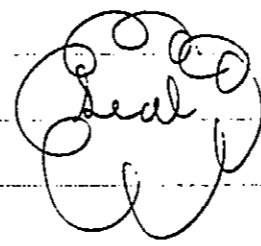
In the matter of the probate of the last will and testament of Alpheus Scull deceased. } Order For Probate
