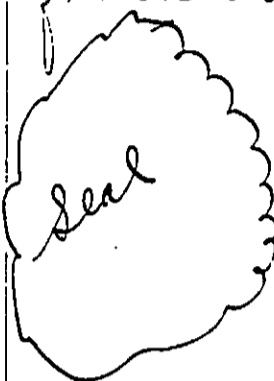
In the Matter of the Probate of the last will and testament of Joel Stelman, deceased. } Order For Probate.
