This day came on to be heard the application of Mary E. And it appearing to the Court that due Notice of the filing of said application has been given in the manner and for the length of time required by law, that no objection thereto has been made or filed, that this Court has jurisdiction of said Estate, and an instrument in writing, purporting to be the last Will and Testament of said Emma Mc Coy Bee, deceased, having been produced and read to the Court, and the evidence (a statement of which is filed herein) having been heard and fully considered by the Court, and it appearing from said evidence that the said Emma Mc Coy Bee is dead, that four years have not elapsed since her death, that the instrument here produced is in fact and in truth, the last Will and Testament of said Emma Mc Coy Bee, deceased, and that it has never been revoked. And it further appearing to the Court, that the applicant herein is nominated and appointed as Independent executrix thereof without Bond or other security, and that she is a proper person to receive said appointment.

It is therefore Ordered, adjudged and decreed by the Court that said application be and is granted, said Will established and proven to be the veritable last Will and Testament of said Emma Mc Coy Bee, Deceased, and as such it is admitted to Probate, and the Clerk will record the same, together with the application, Notice, Return and Proof in the Minutes of this Court. And (as provided in said Will) the appointments therein of Mary E. McCoy, as Independent Executrix thereof without Bond, be and is hereby confirmed, and letters as granted will issue to her upon her taking and filing herein the Oath of office as in such cases by law required, within twenty (20) days from this date. And as further provided in said Will, this Court will have or take no further action or jurisdiction in the matter of said Estate other than to approve an Inventory, Appraisalment and list of Claims of said Estate when filed. It is further ordered that H. Clem Kuhnle, W. J. Curtiss and D. C. Jordan, be and they are hereby appointed Appraisers to appraise the property and effects belonging to said Estate
