Adams as one of my executors of my said will: Now, I do hereby revoke my said will so far only as relates to the bequests of Ten thousand dollars to and the appointment of the said Clement J. Adams as one of my executors.

And I do hereby ratify and confirm my said will in every other respect, it being my intention that Armand T. Nichols shall remain as sole executor of said will to act according to all the several conditions and directions expressed therein.

1. In all things I confirm the codicil to that will dated Novr. 9th 1910 & immediately preceeding this codicil

2. I revoke the bequest contained in Clause 5 of my said will & in lieu thereof if not completed before my death, I desire that a memorial window be donated to the St. James Episcopal Church, situate at the corner of North Carolina and Pacific Avenues, Atlantic City, N.J., at a sum not to exceed fifteen hundred dollars.

3. I revoke the bequest contained in clause 6 of my said will in and by which a certain bequest is made to Mr. & Mrs. John G. Sweet.

4. I revoke the bequest contained in clause 7 of my said will in & by which a certain bequest is made to Stella Dean.

5. I revoke the bequest contained in Clause 11 of my said will & in lieu thereof I give & bequeath to Alfred W. Westney, M.D. my friend and physician of Atlantic City, N.J. the sum of one thousand dollars.

6. I revoke the bequest contained in clause 12 of my said will in & by which a certain bequest is made to the Atlantic City Hospital.

7. I revoke the bequest contained in clause 15 of my said will in & by which a certain bequest is made to the Mrs. Lear McKennie Johnson.

8. I revoke the bequest contained in clause 18 of my said will in & by which a certain bequest is made to Mrs. Ida Pinsker.

9. I revoke the bequest contained in clause 19 of my said will in & by which a certain bequest is made to William Pinsker.

10. I revoke the bequest contained in clause 20 of my said will in & by which a certain bequest is made to Clement J. Adams & remove him as one of the Executors of said will, there by again reaffirming my codicil of Novr 9th 1910.

In all other respects I ratify & confirm my said will of Feby 8th 1908.
