SEventh:- I nominate and appoint Joseph A. McNamee, of the City of Atlantic City and State Of New Jersey; sole executor , without bond, of this, my last will and Testament. Eighth:- I direct that my executor be empowered to make such sales and such investments of my real and personal property as in his opinion may best conserve the interests of my estate.
