I, Ellen. Chase Roberts of Germantown in the City of Philadelphia, in the State of Pennsylvania, Widow, do make, publish and declare this my last will and testament as follows;

(First) I direct all my just debts and funeral expenses be fully paid and satisfied by my executors hereinafter named as soon as conveniently may be after my death.

(Second) I give, devise and bequeath unto my daughter Ellen-Cuthbert Roberts her heirs and assigns, all the right, title and interest I may die possessed of, in, or to the land and premises known as number two hundred and twenty-nine (229) on West Walnut Lane in Germantown aforesaid, which I now hold jointly with my said daughter.

 - (2) The sum of one thousand dollars to be paid to my sister Harriet T. C. Atwater.
- (3) The sum of one thousand dollars to be divided amongst my three nieces Ellen W. Chase, Elizabeth L. Chase, and Catherine W. Chase, share and share alike.
- (4) The residue of my estate derived from the said sale of the said Atlantic City Property shall be divided amongst my daughter Alice Roberts Radmore, my granded aughter Alice R. Preston, andmy grandson Cuthbert Parrish, share and share alike.

(Fourth) I will and direct that the share of my said grandson shall remain in the hands of my executrix and executor my trustees hereinafter named, until he shall have attained the age of twenty two years, and the interest arising from investingthe same shall be paid to him or for his benefit as my trustees deem expedient.

And I further empower them if they shall deem it expedient not to pay over such monies at any time, but keep the same invested and pay the interest arising therefrom to my grandson or for his benefit as they may see fit so long as he may live, and after his death I direct my trustees to pay over such funds to my said granddaugher or her heirs, or such other person or persons as she may by will appoint.

And it is my desire that my late husband's watch, chain and ring shall be given to my grandson Cuthbert Parrish if my trustees shall deem it expedient for him to have it. If they should not so deem it, I give the said watch, chain and ring to my daughter Ellen Cuthbert Roberts to dispose of it as she see fit.

(Eighth) I will and direct that the residue of my estate shall be divided equally amongst my daughters and grand-daughter aforesaid share and share alike in such manner as they may agree upon among themselves.

(ninth) I direct my executrix and executor to pay any collateral inheritance tax chargeable against said legacies out of the corpus of my estate in order that the legatees may receive the full amounts herein named.

(Tenth) And I do hereby constitute add appoint my daughter Ellen Cuthbert Roberts and The Provident Life and Trust Company of Philadelphia in the City of Philadelphia in the State of Pennsylvania Executrix and Executor of and trustees of this my last will and testament, hereby revoking all wills by me at any time hereinbefore made and declaring these presents only to be and contain my last will and testament.
