be paid to them only on the following condition, viz; that they shall not contest this my last will by caveat, appeal from any order of the Surrogate or Orphans Court, by & opposition to its pobate or by proceedings to set aside the same, on in or by any other method or means whatsoever, directly or indirectly. And it is my will that the amounts bequeathed to my daughters shall not be paid to them respectively by my executors until the time or times limited by law for such contests shall have expired, unless Judicial acquiesence' in its validity and probate be sooner made. In case of such contest, the contestant or contestants shall forfeit her or their shares in my estate and the amount thereof shall belong and be paid to the remaining residuary legatees or legatee, as the case may be.
