income to such child or children as shall survive her and the decendants of deceased child or children, and as each child shall attain the age of twenty one years to pay to such child his or her share of the principal; and in case my said daughter shall die leaving no child or children nor decendants of deceased child or children living at the time of her death, the said Trustees shall dispose of the principal of my estate in such manner as may said daughter shall by her Last Will and Testament Direct and appoint, and inccase she shall make no disposition thereof, Then in Trust to distribute among my right heirs.

I nominate constitute and appoint my said wife to be the Executrix of this my will, and I authorize and empower my said Executrix and after her death my said Trustees and the survivor of them to sell and dispose of all or any part of my real estate at public or private sale or sales, for such price or prices, and upon such terms and conditions as seems best and to make all necessary deeds and conveyances thereof without any liability on the part of the purchaser or purchasers to see to the application of the purchase money.
