Sixth: All the rest, residue and remainder of my estate, real personal and mixed, of whatsoever kind or nature and wheresoever four, of which I may die seized and possessed or entitled to, I give and devise unto my Executors and Trustees hereinafter named, or the surviviors or successors, in Trust nevertheless to receive all the issues, incomes, interests, rents and profits therefrom and after deducting all legal charges, commissions and expenses to pay the same unto my said wife Annie L. Stutzbach for and during the whole term of her natural life, and at and upon the death of my said wife Annie L. Stutzbach to pay the same unto my daughter Alice Stutzbach Jones for her sole support and sustenance of or and during the whole term of her natural life, free and discharged from and so as not to be in any way liable for her debts now contracted or which may be hereafter contracted, or any engagements of any husband which she may now have or hereafter take, and from all judicial process to levy upon and attach the same for the payment thereof and she shall not have the power to assign or commute the same.

Upon the failure of my said daughter Alice Stutzbach Jones or of any of my or the children of deceased issue, then my said Trustees shall pay unto grandchildrento leave him or her lawful issue surviving or the children of my brothers August Stutzbach, Theodore Stutzbach and Randolph Stutzbach and my sister Milla Scherff, living at the time, the sum of Two hundred Dollars (\$200.) each, and the remainder of said estate, I direct to be divided unto seven equal parts and I give the one of such seven equal parts unto each of the foregoing corporations, their successors and assigns, to wit:

- 7. Pennsylvania Society for the Prevention of Cruelty to Animals in the City of Philadelphia:

Seventha Should my said wife Annie L. Stutzbach during her life time, or should my said daughter Alice Stutzbach Jones, after the death of my said wife Annie L. Stutzbach deem it to be to the best interest of my estate to change the Trustees serving with them as hereinbefore mentioned they may petition the Orphans! Court for the County of Philadelphia for such change, and the reupon the said Court shall appoint such other Trust Company as may be selected by my said wife Annie L. Stutzbach during her life time and by my said daughter Alice Stutzbach Jones after the death of my said wife, in place and stead of the Commonwealth Title Insurance and Trust Company or such other Trust Company as may be serving as Co-Trustee with them under the term of this my will

Eighth: I hereby nominate, constitute and appoint my said wife Annie L. Stutzbach, my said daughter Alice Stutzbach Jones together with the Commonwealth Title Insurance and Trust Company to be the Executors of and Trustees under this my last will and Testament and for the purpose of paying debt s, making distribution, changing investments and for any other purpose, I hereby give and grant unto said Executors and Trustees full power to sell and dispose of all or any part of my real estate either at public or private sale as they deem proper, and to execute and deliver good and sufficient deeds or other assurances in the law necessary to convey a good and sufficient title in fee simple or otherwiseto the purchaser or purchasers thereof without any responsibility or liability on the part of the purchaser or purchasers to see to the application of the purchase money. Lastly: I have heretofore made my will dated the Seventeenth day of April A. D. 1899 with codicils thereto dated January Seventh A.D. 1904 and October Second A.D. 1906, which I direct to be my last will and codicils should I die within one (1) calendar month from the date of this Will. If I should live for more than one (1) calendar month after the date of this Will, then the foregoing is to be my last will and Testament, and the Will dated April Seventeenth A. D. 1899 and codicils dated January Seventh A. D. 1904 and October Second A. D. 1906 are revoked.
