

Fourth: I give and bequeath unto my Niece, Florence E. Tull, my finger ring containing large opal, surrounded with diamonds.

Fifth: I give and bequeath unto my little namesake Helen Virginia Tull, my finger ring set with four large diamonds; also my writing desk and chair.

Sixth: I give and bequeath unto my Niece, Beatrice my marquise ring set with diamonds.

Seventh: I give and bequeath unto my sister-in-law Carrie Tull my small ring set with garnet and two diamonds.

Eighth: I give and bequeath unto my sister-in-law Mabel Tull my small ring, set with one diamond.

Ninth: I give and bequeath all my table and bed linen which is in my summer home in Ventnor New Jersey, to my two sisters-in-law Carrie And Mabel, share and share alike.

Tenth: I give and bequeath unto my little nephew, Ernest E. Tull, Jr., my husband's gold watch.

Eleventh: I give and bequeath unto my sister-in-law Carrie and Mabel All my china, clothing, and cut glass, share and share alike.

Twelfth: I give and bequeath unto my sister-in-law Carrie Tull the sum of Five Hundred Dollars (\$500).

Thirteenth: I give and bequeath unto my sister-in-law Mabel Tull the sum of Five Hundred Dollars (\$500).

Fourteenth: I give and bequeath unto my Executors and Trustees hereinafter named In Trust Nevertheless the sum of \$3,000, the net income therefrom to be paid semi-annually unto my mother Sarah Tull, for and during the term of her natural life, and upon her death the principal with any accumulated income is to revert to my residuary estate.

Fifteenth: I give and bequeath unto my brother Ernest E. Tull the sum of one thousand four hundred dollars (\$1,400), my wish being that he would apply this sum to the satisfaction of the mortgage which I hold upon his property No. 5444 Pulaski Avenue, Germantown, Philadelphia.

Sixteenth: I give and bequeath unto my Executors and Trustees hereinafter named in Trust nevertheless the sum of Seven thousand Five Hundred dollars (\$7,500), the net income therefrom to be applied to the education, maintenance and keep of my three nieces Florence E. Tull, Helen Virginia Tull and Beatrice M. Tull until they reach the age of eighteen years. Upon reaching the age of eighteen years, I hereby authorize, direct and empower my Executors and Trustees hereinafter mentioned to pay each of the above-named Nieces the sum of Two thousand five hundred dollars (\$2,500). Should either of my aforementioned Nieces die before reaching the age of eighteen years, her or their share or shares shall revert to my residuary estate.

Seventeenth: I give and bequeath unto my sister-in-law Emily J. Beale the sum of Five hundred dollars (\$500) the same to be paid to her as soon as my Executors and Trustees will find it convenient.

Eighteenth: I give and bequeath unto my friend Mrs Charles McCarthy Senior, the sum of two hundred Dollars (\$200) in cash.

Nineteenth: I give and bequeath unto my Executors and Trustees hereinafter named In Trust Nevertheless the sum of One thousand Dollars (\$1,000) the net income therefrom to be applied semi-annually to the education, maintenance and keep of my little nephew Ernest E. Tull, and I hereby authorize, direct and empower my Executors and Trustees to pay the principal of the said Trust Fund of One thousand Dollars unto my said Nephew Ernest E. Tull, when he reaches the age of twenty-one years, and thereafter the said Money to be applied to the education, maintenance and keep of the said Nephew Ernest E. Tull, until he reaches the age of twenty-five years, and thereafter the principal of the said Trust Fund is to revert to my residuary estate.

Twenty-tenth: I give and bequeath the sum of Two Thousand Five hundred dollars (\$2,500) to my brother Francois D. Tull in cash.

Twenty First: All the rest, residue and remainder of my Estate, Real, personal or Mixed of whatsoever kind or nature and wheresoever situated I give, devise and bequeath unto my two brothers, Maurice L. Tull and ~~Harriet~~<sup>Beatrice</sup> B. Tull, share and share alike.

Lastly: I hereby nominate, constitute and appoint my friend and advisor Charles J. Schaefer and my brother Ernest B. Tull to be the Executors and Trustees of this my last Will and Testament, giving them full power and authority to sell and dispose of, for partition or for any other purpose whatever, all or any part of my estate, real, personal or Mixed at either public or private sale or sales, at such time or times for such price or prices and upon such terms and conditions as to them may seem best; and to grant and convey the same to the purchaser or purchasers thereof free and clear from all liabilities for or on account of the application, mis application or non-application of the purchase money or any part thereof. And to my Trustees I give full power and authority to invest and reinvest the trust funds at their discretion and as occasion demands, and to make such changes as they may deem safe and advantageous to the Trust Estates. I also give them full power and authority to sell and dispose for partition or for any other purpose whatever of all or any part of my estate, real, personal or mixed, at either public or private sale or sales, at such time or times, for such price or prices, and upon such terms and conditions as to them may seem best, and to grant and convey the same to the purchaser or purchasers thereof free and clear of all trust charges or liabilities for or on account of the application, mis application or non-application of the purchase money, or any part thereof.

My Executors and Trustees are not to be required to file any bond of whatever character, give or furnish any surety for the faithful performance of their duties or for the carrying out of the provisions of this my last will and testament in this State or County or in any other State or County.
