SEVENTH: If at the time of my death, the following named servants are in my employ, then I give and bequeath as follows:

To Thomas J. Burns, the sum of One thousand (1000) dollars.

To Charles Thomas, the sum of One thousand (1000) dollars.

To Frank C. Seiberling, the sum of One thousand (1000) dollars.

To Agnes Lyons, the sum of One thousand (1000) dollars.

To Katharine McGuire, the sum of One thousand (1000) dollars.

EIGHTH: I give and bequeath to Katie Boyle (dressmaker), the sum of Five hundred (500) dollars.

NINTH: I direct my Executors, hereinafter named, to select some reliable Trust Company and pay over to them the sum of Five hundred (500) dollars, to be held in Trust, the income thereof to be used in keeping in perpetual order and repair the burial lot in Laurel Hill Cemetery, wherein my body will be laid.

TENTH: I direct that all the foregoing legacies shall be paid to the respective legatees free and clear of any and all collateral inheritance, or other inheritance or succession taxes, and any such tax or taxes shall be paid out of my residuary estate.

ELEVENTH: ALL the rest, residue and remainder of my estate I give, devise and bequeath to my Executors hereinafter named, to be held by them upon the following uses and trusts: To invest and keep invested the principal of the said residue, collect the rents, issues and profits thereof, and pay over the entire net income from time to time as the same may accrue, to my sister, Matilda J. Knowles, during the term of her natural life, and upon the death of my said sister, or in the event of her dying during my lifetime, to pay over the said net income to my two nephews, Archibald Campbell Knowles and Nathaniel Knowles, and my niece, Anna L. Sartori, in equal parts, share and share alike, upon the death of any one of my said nephews or niece, to pay the said net income to the two survivors in equal parts, share and share alike, and upon the death of any two of them, to pay said net income to the survivor during the term of his or her natural life; after the death of all of my said nephews and niece, to divide the principal of said residue among

their children then surviving, in equal parts, share and share alike.

If either of my said Executors and Trustees should die or resign before the termination of the Trust hereby created, I give full power and authority to the remaining Trustee to appoint such other person or corporation as in his discretion he may select to be co-trustee with him under this will.

TWELFTH: I nominate and appoint my two nephews, Archibald Campbell Knowles and Nathaniel Knowles as Executors and Trustees of and under this my last will and testament, with full power to sell and dispose of any and all my real estate, either at public or private sale, to such persons or person and for such price or prices, and upon such terms as they in their discretion may deem best, and to convey the same to the purchaser or purchasers thereof, without liability on their part to see to the application of the purchase money.

CODICIL

I, EMILY BAKER ELLIOT, hereby make and publish the following Codicil to my last Will and testament, dated the Twelfth day of November, A. D. 1917:

FIRST: I revoke the legacy of Five thousand dollars given to Archibald Campbell Knowles in the Fourth item of my said will.

SECOND: I revoke the legacy of Two thousand dollars given to Margaretta Walsh (formerly Margaretta Knowles) in the Fourth Item of my said will.

THIRD: I revoke the legacy of Ten thousand dollars given to the Rector and Church Wardens of St. Albans Protestant Episcopal Church at Olney, Philadelphia, in the Sixth Item of my said will.

FOURTH: In the Eleventh Item of my said will I have directed that after the death of my nephews and niece herein named, the principal of my residuary estate shall be divided among the children of my said nephews and niece then surviving, in equal parts, share and share alike. I now direct that Margaretta Walsh (formerly Margaretta Knowles), daughter of my nephew, Archibald Campbell Knowles shall be excluded from such division, and that she shall receive no part or share of my said residuary estate, but the whole of the principal thereof shall be divided among the other children, of my said nephews and nieces then surviving, in equal parts, share and share alike.

FIFTH: I revoke the appointment of my nephew, Archibald Campbell Knowles as one of the Executors and Trustees of and under my said will, and I now nominate and appoint as said Executor and Trustee, together with Nathaniel Knowles, my grand-nephew, Frank A. Sartori, Jr., with all the powers conferred upon my Executors and Trustees by the Twelfth Item of my said will.

SIXTH: Subject to the alterations and revocations contained in this Codicil, I hereby ratify and confirm the provisions of my said last will and testament.
