First - I give and bequeath the sum of one thousand Dollars to the Provident Life and Trust Company of Philadelphia IN TRUST to invest the same and apply the net income therefrom to the preservation of the monument and stones, and the care of the grass, in the cemetery lot in the Summit Section of West Laurel Hill Cemetery in the name of my father, George Whiteley.

Second - I order and direct my executors hereinafter named to sell my house at Buckhill Falls, Monroe County, Pennsylvania, together with the contents at the same time if possible, and to make proper deed of conveyance and bill of sale therefor without any obligation on the part of the purchaser to see to the application of the purchase money.

Third - I order and direct my executors hereinafter named to sell my house No. 2204 Spring Garden Street in the City of Philadelphia, and to make and execute proper deed of conveyance for the same without any obligation on the part of the purchaser to see to the proper application of the purchase money.

Fourth - The purchase money of the houses hereinbefore mentioned shall become a part of my general or residuary estate.

Fifth - I give and bequeath the sum of Twenty-five thousand (\$25,000) Dollars to Sarah B. Sullivan, and a square package in my safe deposit box in the Guarantee Trust and Safe Deposit Company labeled with the name of the said Sarah B. Sullivan, also my mother's diamond and pearl brooch, and sable fur piece.

Sixth - I give and bequeath to Elizabeth H. Colladay, the sum of Ten Thousand (\$10,000) Dollars and also pair of silver vegetable dishes and two platters, one dozen King pattern tea spoons, and Medallion of Queen Louise.

Seventh - I give and bequeath to Ida May Finley of York, Pennsylvania, the sum of Ten thousand (\$10,000) Dollars and choice of books and catalogues.

Eighth - I give and bequeath to Marie LeMande Young Five thousand (\$5000) Dollars and also picture, Pennell's Satin Look, and Corregio's Cherubs.

Ninth - I give and bequeath to Sara D. McFeeter the sum of Ten thousand (\$10,000) Dollars and my mother's gold watch.

Tenth - I give and bequeath to Annie Rex Horster the sum of Two thousand (\$2000) Dollars.

Eleventh - I give and bequeath the sum of One thousand (\$1000) Dollars to William Duffield Robinson.

Twelfth - I give and bequeath the sum of Five hundred (\$500) Dollars to Anna Brown Flanagan.
