FIRST: As to such Estate as it hath pleased GOD to intrust me with, I dispose of the same in manner following: VIZ:-

SECOND: I order and direct that all my just debts and funeral expenses, be fully paid and satisfied by my Executors, hereinafter named or the survivor of them, as soon as conveniently may be after my decease.

THIRD: All the Rest, Residue and Remainder of my Estate, Real, Personal and Mixed, whatsoever and wheresoever the same may be at the time of my decease. One full equal third part or share thereof unto a Daughter of my Wife, aforesaid, a Maria Knorr, of Nueremberg, Germany. And the remaining one full equal third part or share thereof unto my Grand-child Frank Ruff, child of my aforesaid Daughter, Henrietta Ruff.

PROVIDED that in the event of the death of either of the aforesaid, then their respective share revert to the issue of their body and if there be no issue then such share they would have received if living, shall revert to the survivor or survivors of the three legatees their and each of their heirs and assigns forever.
