I, BELLA V. CHATMAN, of the City of Philadelphia, being of sound and disposing mind, memory and understanding, do make, publish and declare this my last will and testament, hereby revoking any and all wills by me at any time heretofore made.

IMPRIMIS: I order and direct my Executor hereinafter named to pay my just debts and funeral expenses as soon as conveniently may be done after my decease.

ITEM: I give, devise and bequeath unto my step son, ALBION C. CHATMAN, 3rd, the pair of diamond ear rings, the diamond stud, diamond brooch, diamond solitaire ring, and ruby, sapphire and diamond ring, all of which belonged to his Mother.

ITEM: I give, devise and bequeath unto my Cousin, Mrs. LULU V. LARGE, my three stone diamond ring.

ITEM: I give, devise and bequeath unto my friend, Mrs. ELLA PARKER, my two stone diamond ring and my brass bed.

ITEM: I give, devise and bequeath unto Dorothy T. Chatman, daughter of my step son Albion, her grandmother's watch and chain, and to Catharine Chatman, also daughter of Albion, my watch and chain.

ITEM: I give, devise and bequeath unto my step son, ALBION C. CHATMAN, 3rd, the sum of Ten Thousand Dollars; to my aunt, Mrs. EMMA HARVEY, the sum of Two Thousand Five Hundred Dollars (which is to include the sum of \$500.00 payable to her from the estate of my mother, Virginia Farr); to Mrs. KIZZIE CHATMAN, wife of Albion C. Chatman 3rd, the sum of One Thousand Dollars; to my step son, EDGAR T. CHATMAN, the sum of One Thousand Dollars, and to my friend, Mrs. ELLA PARKER, the sum of Two Thousand Dollars.

ITEM: All the rest, residue and remainder of my estate, real, personal and mixed, whatsoever and wheresoever situate at the time of my death, I give, devise and bequeath to the legatees named in the preceding item of this, my will, to be divided among them in the proportion that their respective legacies bear to the total of the money legacies therein bequeathed.

If, for any reason my estate should not be sufficient to pay in full the money legacies bequeathed in the preceding item, of this my will, then I direct that said money legacies shall abate in like proportion.

ITEM: I order and direct my Executor hereinafter named, to sell and convert into cash, all the assets of my estate not hereinbefore specifically devised, and for that purpose I order and direct him to sell any and all real estate of which I may die seized and possessed, either at public or private sale, for the best price or prices which may be offered for the same, and to make, execute and deliver to the purchaser or purchasers thereof good and sufficient deeds or other assurances in the law, granted and conveying the same in fee simple, without any liability on the part of the purchaser or purchasers as to the proper application of the purchase money.

ITEM: I nominate, constitute and appoint my step son, ALBION C. CHATMAN, 3rd, Executor of this my will.
