To hold, invest and reinvest the same, collect the income thereof and to pay Eight thousand Dorlars of such income, in equal quarter yearly payments to my wife Evelyn S. Donchian, during the term of her natural life.

Whenever the annual revenue derived from my estate is insufficient to yield said sum of Eight thousand Dollars, my said Trustees are hereby authorized and directed to provide the deficiency out of the principal of my said estate.

SIXTH: The provision; herein before made for my wife shall be in lieu of all her right of dower in my estate and are conditional upon her consent that the proceeds of all my life insurance policies wherein she is designated as beneficiary be transferred to my Executors and Trustees. .

SEVENTH: Upon the death of my wife, Evelyn S. Donchian, I hereby give, devise and bequeath the entire principal of my estate, including any accumulated income, unto the "American Board of Commissioners for Foreign Missions", incorporated in Massachusetts in 1812, and having a branch office at #105 East 22nd Street, Borough of Manhattan, City of New York, upon condition that the corpus of my said estate Be segregated as the "Jehn B. Donchian Foundation Fund and that the income derived therefrom be expended in the City of Diarbekar, Asia Minor, my birthplace, and also in the cities of Mardon and Harpout, Asia Minor for the charitable, educational, religious or elemosynary purposes of asylums, hospitals, schools and churches in said cities.

EIGHTH: I hereby nominate, constitute and appoint my wife Evelyn S. Donchian, Executrix, John A. Boyajean of Jersey City, New Jersey, Garabed T. Pushman and Jacob B. Bazazian, both of Chicago, Illinois, and the Guaranty Trust Company of New York, Executors of

and Trustees under this my last Will and Testament, and hereby authorize and empower them, Until or such of them as shall qualify, the survivors or survivor of them to sell at public or private sale, all or any part of my real or personal property upon such terms and under such conditions as they may deem advisable, and to make, execute and deliver good and sufficient deeds of conveyance and instruments of transfer thereof, and I further direct that no bond or other security be required of my said Executors and Trustees' for the faithful performance of their duties as such.

NINTH: I hereby authorize and direct my Executors and Trustees of such of them shall qualify, the survivors or survivor of them, to convert my estate into cash with reasonable dispatch, but without sacrifice.

As my estate is thus converted, I hereby authorize and empower said Executors and Trustees to hold, invest and reinvest the proceeds in securities allowed by law for trust funds, and when the conversion of my estate shall have been fully completed, then I hereby direct that the trust created in and under this my last Will and Testament shall thereafter be administered by said Evelyn S. Donchian and said Guaranty Trust Company of New York, or such of them as shall qualify or the survivor of them.

I particularly direct that during the life of said trust, and at all times after my residuary legatee, the "American Board of Commissioners for Foreign Missions", becomes seized and possessed of the principal of my estate, the same shall be kept securely invested in the United States of America, and that no part of such principal shall ever be removed from the United States to any foreign country or jurisdiction.
