 Carlton Godfrey, of full age, being duly sworn, according to law, on his oath says that he is the President of the Guarantee Trust Company of Atlantic City, a corporation of the State of New Jersey; that said corporation has created and set apart a fund of One Hundred and Fifty Thousand Dollars (\$150,000.00), specially devoted to securing its liabilities as assignee, receiver, administrator, guardian, and trustee, in accordance with the provisions of an act of the Legislature of the State of New Jersey entitled "An Act concerning Trust Companies, (Revision of 1899)", approved March twenty-fourth, one thousand eight hundred and ninety nine, (Laws of 1899, page 452), and has duly deposited with the Register of the Probate Court of the State of New Jersey, according to the schedule prescribed by Rules 9, 10, and 11 of that Court, securities which represent the said fund, and that the liabilities of said corporation for which the fund aforesaid is specially responsible, as provided in Section 9 of said Act, including all funds and securities of the trust about to come to it under its contemplated appointment as Guardian of the Estate of Clara Frieda Schneider, minor, do not exceed ten

times the value of such specially created and deposited fund. And deponent further says that there is herewith annexed and made a part of this statement and affidavit, a copy of the latest published general statement of the resources and liabilities of the said corporation and that said statement is of a date within six months of the date of the application made by said Guarantee Trust Company for appointment as Guardian of the Estate of Clara Frieda Schneider, minor.
