Decree for Sale.

The order to show cause made in this matter on the fifteenth day of February, nineteen hundred and five, having been advertised and published according to law, and the Court having heard and examined the allegations and proofs of the Guaranty Trust Company, administrator of the Estate of Emery D. Ireland, deceased, and of the parties interested, and it appearing on full examination that the personal estate of Emery D. Ireland, the said intestate, is not sufficient to pay his debts and that the said Guaranty Trust Company, administrator as aforesaid, has applied all of the personal estate that has come to its hands to the payment of said debts and that there is a deficiency amounting to the sum of Eight Hundred Sixty-nine Dollars and Eighty-one cents, and Emily E. Ireland, widow of said Emery D. Ireland, deceased, having filed in this Court her consent that said lands be sold free and clear of dower therein; It is, therefore, on this Eighteenth day of April, A.D. nineteen hundred and five, ordered that the said Guaranty Trust Company, administrator as aforesaid, sell the following tracts of land whereof the said Emery D. Ireland died seized to viz. A certain one half interest in six vacant building lots, known as Nos. 15, 16, 17, 18, 19, and 20 on a plan of lots of McLaughlin & Grove, filed in the Clerk's Office of Atlantic County, which said land is situate in the City of Egg Harbor City, County of Atlantic and State of New Jersey, to raise the aforesaid sum of Eight Hundred Sixty-nine Dollars and Eighty-one cents for the payment of the debts of the said decedent, and that after making such sale that the said Guaranty Trust Company report the same to this Court for its approval and confirmation; and it is further ordered that such sale shall be made free and clear from the right or estate in dower of Emily E. Ireland, widow of said Emery D. Ireland, deceased, and that said lands may be sold at public or private sale.
