To Honorable C. A. Higbee, Judge of the Orphans' Court, In and for the County of Atlantic.

The petition of Augusta Bolte, of the City of Atlantic City, in the County of Atlantic and State of New Jersey, respectfully shows:

(1) Your petitioner is the widow of William H. Bolte, deceased, who died on the third day of May nineteen hundred and seven, leaving a last will and testament, dated the twenty-sixth day of March, nineteen hundred.

(2) That on the twenty-fourth day of May, nineteen hundred and seven, your petitioner and her sons, August F. Bolte and G. Arthur Bolte, the executors therein named, presented the said will to the Surrogate of Atlantic County for probate.

(3) That Charles M. Bolte and Annie Devlin two of the children of the said William H. Bolte, deceased, by his first wife, lodged with the said Surrogate on the fourteenth day of May nineteen hundred and seven, a caveat against the probate of said last will and testament of the said William H. Bolte, deceased.

(4) Your petitioner further shows that she has little means of her own and is without money to provide for her support and maintenance, and that having due regard to the wealth of her husband, her condition in life and the manner in which she was left by the said William H. Bolte, deceased, during his lifetime, there should be paid to her at least the sum of one hundred dollars per month for her support and maintenance, and that a further allowance should be made out of the income from the estate of her said husband, and, if necessary, out of the principal thereof to carry on the litigation for the purpose of obtaining a probate of the last will and testament of her said husband.

(5) Your petitioner further shows that on the twenty-third day of May, eighteen hundred and seventy-five, she was ceremonially married to the said William H. Bolte by August Stephany, Esquire, one of the Justices of the Peace, in and for the County of Atlantic, in the State of New Jersey, and that she has in her possession and ready for production the certificate of the said Justice in verification of this allegation.

(6) And your petitioner further shows that she was living with the said William H. Bolte as his wife at the time of his death.

The premises considered, your petitioner prays:

(1) That an order be made upon the administrator pendente lite of the estate of the said William H. Bolte, deceased, or other persons having custody of his estate, for the payment of a suitable allowance for her support and maintenance out of the income of the said estate, and for such further allowance out of the said income, or, if need be, out of the corpus of the estate, as may be necessary to meet the expenses incurred or to be incurred in conducting the contest concerning the probate of the said will.

(2) And for such other and further relief as to your Honor shall seem meet and agreeable to equity under the practice of this court.

Atlantic County Orphans' Court.

of William H. Bolte, deceased, } Order for Allowance to Widow, &c.
who died testate.

This matter coming on to be heard upon due notice in the presence of Bolte & Albertson, proctors for the petitioner, Augusta Bolte, and S. Barberon Hinkle, proctor for the co-executors, and it having been admitted in open court by all parties concerned that the said Augusta Bolte was ceremonially married to the said William H. Bolte, deceased, on the twenty-third day of May, eighteen hundred and seventy-five, by August Stephany, Esquire, one of the Justices of the Peace, in and for the County of Atlantic in this State, and that she was living with the said William H. Bolte, deceased, as his wife at the time of his death; and it further appearing that the property of the said William H. Bolte, deceased, produces a net income of approximately two thousand dollars per year, and that it consists of personal property approximating four thousand dollars and upwards and of real estate approximating thirty-five thousand dollars and upwards; and it further appears that Charles M. Bolte and Annie Devlin have filed a caveat to the probating of the paper writing purporting to be the last will and testament of the said William H. Bolte, deceased; and it further appearing that by an order bearing even date herewith the said Augusta Bolte has been appointed administratrix pendente lite of the estate of the said William H. Bolte, deceased.

It is on this twenty-ninth day of May, nineteen hundred and seven, on motion of Bolte & Albertson, proctors for the said Augusta Bolte, ordered that Augusta Bolte, widow of the said William H. Bolte, deceased, the sum of forty dollars per month for her support and maintenance out of the income of the estate of the said William H. Bolte, deceased, pending contest against the admission of the said alleged will to probate as the last will and testament of the said William H. Bolte, deceased.

And it is further ordered that the said administratrix pendente lite be allowed the sum of one hundred dollars out of the income from the estate of the said William H. Bolte, deceased, or if need be out of the corpus of the estate, for the purpose of retaining counsel to try the said contest.

And it is further ordered that the court reserves the right to make other and further allowance for counsel fees and expenses incurred in conducting such contest concerning the
