I was born in Deepkany Russia, on the 15 day of Mar, anno Domini 1881; I now reside at 112 N. Houston Ave Atlantic City N.J. I emigrated to the United States of America from Liverpool England on the vessel Dominion; my last foreign residence was Winnipeg Canada.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas II Emperor of all the Russias of which I am now a citizen subject; I arrived at the port of New York City by rail, in the State Territory of New York on or about the 10 day of May, anno Domini 1905; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
