I was born in Stockport, England, on the 28 day of July, anno Domini 1869; I now reside at 4 Maryland Pk Atlantic City, N.J. I emigrated to the United States of America from Liverpool, England, on the vessel Cephalonia; my last foreign residence was Oldham, England.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George V King of Great Britain & Ireland, of which I am now a citizen subject; I arrived at the port of Boston, in the State of Mass, on or about the 11th day of Nov, anno Domini 1895; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
