I was born in Antwerp Belgium, on the 21st day of June, anno Domini 1873; I now reside at 609 Boardwalk Atlantic City, N.J. I emigrated to the United States of America from Antwerp Belgium on the vessel Friesland; my last foreign residence was Antwerp Belgium.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Albert I King of the Belgians, of which I am now a citizen-subject; I arrived at the port of New York City, in the State of New York, on or about the 9th day of Nov, anno Domini 1896. I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
