It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas II Emperor of all the Russias, of which I am now a citizen-subject; I arrived at the port of Baltimore, in the State of Maryland on or about the 22 day of Feb'y, anno Domini 1905; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
