It is my bona fide intention to renounce forever all allegiance, and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George V King of Great Britain and Ireland, of which I am now a subject; I arrived at the port of Philadelphia, in the State of Pennsylvania on or about the 19th day of January, anno Domini 1887; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
