I was born in Dublin Ireland, on the 9th day of July, anno Domini 1880; I now reside at 20 Haddon Ave Atlantic City, NJ. I emigrated to the United States of America from Queenstown Ireland on the vessel Quernia; my last foreign residence was Kilsare Ireland.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to George V King of Great Britain and Ireland of which I am now a citizen subject; I arrived at the port of New York City, in the State of New York on or about the 13th day of April, anno Domini 1903; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein: SO HELP ME GOD.
