(Invalid for all purposes seven years after the date hereof)

I, Paul Hubert, aged 37 years, occupation farmer, do declare on oath that my personal description is: Color white, complexion dark, height 5 feet 9 inches, weight 160 pounds, color of hair brown, color of eyes brown, other visible distinctive marks none.

I was born in Saghy Hungary on the 11th day of April, anno Domini 1878; I now reside at Dorothy, New Jersey.

I emigrated to the United States of America from Fiume Hungary on the vessel Carpathia; my last foreign residence was Saghy Hungary.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Francis Joseph Emperor of Austria and apostolic King of Hungary, of whom I am now a subject; I arrived at the port of Philadelphia, in the State of Pennsylvania, on or about the 12th day of November, anno Domini 1905; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:

I was born in Bodder Germany on the 11th day of July, anno Domini 1872; I now reside at Smith Landing, New Jersey.

I emigrated to the United States of America from Bremen Germany on the vessel aller; my last foreign residence was Bodder Germany.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to William III German Emperor, of whom I am now a subject; I arrived at the port of New York City, in the State of New York, on or about the 25th day of March, anno Domini 1889; I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
