I was born in Volinsky Russia on the 28th day of August, anno Domini 1887; I now reside at 1317 1/2 Conn. Ave. Atlantic City, New Jersey (Give number, street, city or town, and State.) I emigrated to the United States of America from Liverpool England on the vessel Kraskowe; my last foreign residence was Volinsky Russia.

It is my bona fide intention to renounce forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Nicholas 2nd Emperor of all the Russias, of whom I am now a subject; I arrived at the port of Philadelphia, in the State of Pennsylvania, on or about the 8th day of October, anno Domini 1906. I am not an anarchist; I am not a polygamist nor a believer in the practice of polygamy; and it is my intention in good faith to become a citizen of the United States of America and to permanently reside therein:
