I emigrated to the United States of America from Antwerp, Belgium on the vessel Haverford-American line from Liverpool; my last foreign residence was Hamme-Durme, Belgium. I am un married; the name of my wife is Culalie Vermorgen; she was born at Maerzke, Belgium and now resides at Hamme, Belgium.
