A. PREPARE

1. CONSULT: House Histories: A Guide to Tracing the Genealogy of Your Home by Sally Light, (Reference Section, R722.37)

A how-to book which leads the researcher through dating the house through architecture, finding out who lived in the house, ways to find old records, procedure for getting the house listed on historic register, and much more useful information.
