The opening day of the 1916 deer season was marred Wednesday last by the fourth fatality similar amendments. If this passes, amendin four years, when Frank Dixon, aged 38 years, of Estelville, was shot and killed by Fred Hensel, a nineteen-year-old neighbor, Hensel had taken a stand in the woods near Estelville and Dixon worked his way through the brush, in order to drive out the quarry. Seing the bushes move near him, Hensel shot he was hit. The wounded man was hurried to the public property. Hensel at once gave himself up, but was released later on his own recognizance, the authorities finding the shooting purely accidental. The young man, who is a graduate of the High School at this place, is in a state of nervous collapse over his terrible mistake and relatives fear his life is blighted by the tragedy. Dixon is survived by a wife and daughter. The accident occurred about eight o'clock in the morning. Funeral services for the slain hunter will be held at noon to morrow from "Tasta residence itt Estelville.

In each instance the tragedy was wholly accidental. It was estimated that more than three thousand gunners were in the deer woods Wednesday morning last, most of them within gunshot of each other. Part of these were on stands, the others working through the brush driving out the deer. So far as can be learned from twenty-five to thirty deer were killed in Atlantic County. Store this selected seed in barrels, baskets or crates which have never contained potatoes before: not guilty. at temperature of 85 degrees during sweating period, then afterward keep at 50 to 55 degrees. not guilty. Mark container an selected seed.

When taking potatoes from storage throw out all potatoes showing black rot spots. Just before bedding treat seed by immersing in

Moreover, gunners" would know where and when to expect a deer as the baying of the hounds would betray their proximity. The law should be amended to compel every hunter to wear red coats and hats, as is the case in other states where experience has domonstrated the wisdom of such a statute

The pleasure of deer hunting may be divided into three parts, namely : first-camping out for a period of several days in the woods, next to nature, in itself a recreation and source of health; second-the "music" of hounds on the trail of deer, which is a greater pleasure to sportsmen than the actual killing, so much so that many gunners would rather go out into the woods without a gun and listen to their dogs trailing the deer than to kill the animals present methods; third-killing the game. Many a days sport is spolled by thoughts of a wounded deer left in the brush to suffer and die. After every season the carcases of a number of animals are found in the woods, decomposed, or later on only the bones left to tell the shameful tale of suffering imposed by an inhumane law. Some of these animals suffer for weeks before death, others, fortunately die from loss of blood in a few hours. But in those few hours, wounded unto death, they will offtimes travel many miles and only by the use of a hound can they be found in the dense undergrowth that prevails in most of the deer woods The mental picture of a wounded deer suffering agonies sends many gunner home with his outing uttarly minet The only proper deer law is one that permits

hunting, later, in the year, with dogs, for a period of from ten to fifteen consecutive days. There would probably be less deer killed with the use of dogs, but the number bagged would be greater, because every seriously wounded animal would be found and put out of his misery. With such a season' the danger of accidental shooting, which has in four year cost the lives of four gunners and brought untold suffering to not only the families of the deceased but to the unfortunate gunners who were responsible, would be greatly lessened. The sport would be more humane and give better satisfaction to the host of sportsmen, who would be able to look forward with genuine pleasure to a few days in the deer woods without worry to themselves and their loved ones.
