

# JAIL DOORS YAWN FOR GIRL WHO SHOT FATHER

MARY MANGRO LIBERATED  
ON BAIL

Two Other Homicide Indictments  
Returned By Grand Jury Judge  
Cole Hears Numerous Criminal  
Cases and Takes Pleas

Arraigned before Justice Manuel Kallich last Tuesday to answer the charge of murdering her father on October 8 last, Mary Magro, an Italian girl of Atlantic City, pleaded "not guilty" to the unusual charge and on motion of her counsel, Frank Smathers, was released on \$5,000 bail. This was allowed by the Court owing to the fact that a Coroner's jury exoner-

ated the girl and also because she has a number of brothers and sisters to care for. Bond was furnished by an uncle, Nicholas Tripician, for her appearance on November 12.

Plena of not guilty were received by Justice Kalisch from John Williams, indicted for the murder of his common law wife, and Samuel

Smith, indicted for the murder of Nelson Christy. John J. Crandall was appointed a counsel in both cases and November 12 was set as the tentative date of their trial.

William Waddell, adjudged guilty by Judge Cole for petty larceny, was fined \$75, payable \$2 per week. The charge was preferred by Ida Peterson, who reluctantly testified that he stole her coat, and some jewelry to give to another woman.

William Peterson, Nicholas Beardsuto, William Jouglaas and Otto Gale were asked on trial charged with the theft of an automobile tire from Harrison Cook, of the Hesvide Hotel. Gale pleaded guilty, but the other

Three men entered pleas of not guilty. Gale, Scaurtulo and Douglass were all found guilty and Peterson was acquitted. Gale was sentenced to serve a term of six months in the County Jail, while Scaurtulo was ordered to pay a fine of \$50 and Douglass was released on suspended sentence. Gale was the man who inspired the theft, according to his own admission, but the others had been present when the fire was stolen or when it was sold.

Judge Cole held a session Wednesday, after which Criminal Court was adjourned until next Monday. The cases disposed of were:

**Next Governor Will Have Big Patronage At His Disposal.**

The next Governor of New Jersey will have the appointment of many important State officers. The salaries of these officers will aggregate more than \$250,000 annually. Aside from the State Treasury and State Comptrollership that will be filled by the Legislature during the next gubernatorial term, the new Governor will have the following appointments:

Attorney General, Clerk in Chancery, Banking and Insurance Commissioner, State Road Commissioner, three members of the Civil

Service Commission, three members of the State Water Supply Commission, Commissioner of Public Reports, State Librarian, four members of the State Board of Assessors, four members of the State Board of Health, Chief Justice and six Associate Judges, four Circuit Court Judges, three members of the State Riparian Commission, six State Prison Inspectors and a member of each of twenty-one County Tax Boards.

# STOKES TRUE PROGRESSIVE

Record of the Republican Candidate Is One of Many Needed Reforms.

## HIS PLACE IN HISTORY.

Trenton, Oct. 21.—"When the history of New Jersey for the last century comes to be written," said a member of the supreme court here this week, "it will be found that the greatest factor in the building of the commonwealth during that period."

This remark, however, more than passing attention in view of the fact that acting governor James F. Fidler and Everett Colby, the Progressive candidate for governor, have been going round the state for the last week or two attacking in a personal way the reputation of former Governor Stokes, the Republican candidate for governor, and insinuating that he is a reactionary in politics and that, as they put it, with the "same old gang."

Both Fidler, the Democratic candidate, and Colby, the Progressive candidate, know perfectly well that Stokes was strenuously opposed this year for the nomination for governor by the old time Republican leaders with whom they now charge him with being associated. They also know that former Governor Stokes deserves the credit for building and putting through more progressive and constructive legislation than any other man identified with the public affairs of the state in the last twenty-five years. They not only know this, but neither Mr. Fidler nor Mr. Colby can point to one single piece of constructive legislation or to one policy of state while in office that either of them can be credited with in his political career.

Mr. Stokes was superintendent of the public schools at Millville when he was first elected to the house of assembly in 1891. Ever since that time he has given the public school system of New Jersey his close attention, and it is due to his intelligent and unrelenting zeal that the schools of New Jersey today take front rank in the public school system of the United States. Through his efforts the system has been improved not only in an educational sense, but by reason of his revision of the railroad taxation laws while he was governor. Several millions of dollars are now paid annually to the local school districts from this revenue.

The first distinctly progressive message delivered by a governor of New Jersey was found in the inaugural address of Governor Stokes to the legislature of 1905. It attracted unusual attention in other states and received the warm approval of President Roosevelt elected in the same year as Governor Stokes. In his address Mr. Stokes said:

"In the work before us let us remember that we are a government for the people and for the people. It may be our duty to justify their trust by administering the affairs of the state for the people and for them only. Let us avoid a state toward special interests. Let no cheap demagoguery attract our councils. Let us be guided by the public good."
