NO EXCUSE FOR BACHELORS IN JERSEY, CENSUS PROVES

Women Greatly Outnumber Men—Total Population 2,844,842.

Since 1905 New Jersey has gained 700,000 in population, making a total of 2,844,842 residents in the State. Despite this increase, the number of males between the ages of 15 and 19 years has decreased by 25,000. On the other hand, females between the same ages have increased in number by 77,000. Males from 15 to 19 show an increase of 21,000 and females from 15 to 19 a decrease of 17,000. The ratio between the total number of males and females is virtually the same as 10 years ago, the number of white females exceeding the number of white males by about 15,000.
