Ninth: I do give to my executor full power and authority to grant, bargain, sell and convey any or all of my lands and real estate as well as any or all of my personal property to any person or persons in fee simple or otherwise, at public or private sale at such times and upon such terms as he shall think fit.

Tenth: I do hereby constitute and appoint my friend, Charles A. Stewart, executor of this my last will and testament.
