Deponent further says that the said Sophie C. Bannibr did thereupon with the aid of this deponent affix her marks to the aforesaid wills and did publish, pronounce and declare the said writings to be her last will and testament and that at the time of the doing thereof the said Sophie C. Bannibr was of sound and disposing mind, memory and understanding, so far as she knows and as she verily believes.

Deponent further says that the said Elisabethe Meister one of the other subscribing witnesses was present at the same time and signed her name as witness to the said writings together with this deponent in the presence of the said testatrix, and that this deponent and the said Elisabethe Meister signed their names as witness thereto in the presence of the said testatrix and of each other and at the request of said testatrix. That immediately afterward the said testatrix requested the said Ferdinand Waschow also to sign his name as witness thereto after declaring to him that the marks affixed to said writing were made by her and that the said writings were her last will and testament, whereupon the said Ferdinand Waschow affixed his name as witness to the said writings.

Deponent further says that she is well acquainted with John H. Bannibr, the husband of the late Sophie C. Bannibr and knows that he now lives at Egg Harbor City, that the said John H. Bannibr was not present at the time of the making, publishing and declaring of the said will by the said Sophie C. Bannibr.

Deponent further says that when she drew the aforesaid writings the said testatrix showed her two deposit books showing deposits in The Philadelphia Saving Fund Society, one in the name of Sophie C. Bannibr and one in the name of John H. Bannibr in trust for Sophie C. Bannibr; and that said testatrix also showed to this deponent a deposit book in the name of said testatrix showing a deposit in The Western Saving Fund Society of Philadelphia.

Deponent further says that after the said writings aforesaid were signed by testatrix and the witnesses, this deponent placed one of the writings in the deposit book of The Philadelphia Saving Fund Society, and the other writings this deponent placed in the deposit book of The Western Saving Fund Society of Philadelphia.

The condition of this obligation is such, that whereas the surrogate of the county of Atlantic, State of New Jersey, has appointed John H. Bannibr Administrator with the
