Sixth. I give and bequeath to my said Executors, the further sum of Twenty Thousand Dollars In Trust nevertheless, the same to invest and keep invested as constantly as may be practicable in such securities as they may deem most safe and advantageous to produce interest or dividend and income and to collect, get in and receive the interest or dividends and income thereof and pay the same over, as got in and received into my niece Anne M. wife of Robert D. Pruitt, into her hands and upon her own receipt, notwithstanding her coverture, for her separate use during her natural life, and upon the decease of the said Anne M. Pruitt, then to pay the said principal sum of Twenty thousand Dollars unto such of her children and Grandchildren then living and in such shares and proportions as she, the said Anne, by her last Will or any writing in the nature thereof by her signed, notwithstanding her coverture, shall direct and appoint, and for the want of such direction or appointment, then to pay the same to all the children of her the said Anne then living and the issue of any of them then dead in equal shares, so however, that the issue of any such deceased child shall take, if but one, solely, and if more than one, then equally among them, such part and share only as his, her or their deceased parent would have taken if living.

Seventh. I give and bequeath to my said Executors the further sum of Five thousand Dollars, In Trust, nevertheless, the same to invest and keep invested as constantly as may be practicable in such securities as they may deem most safe and advantageous to produce interest or dividends and income and to collect, get in and receive the interest or dividends and income thereof and pay the same over as got in and received into my niece Susan Amanda Bowen (daughter of my

late brother Asma P. Bowen, deceased) into her hands and upon her own receipt, for her separate use free from the control of any husband she may marry, during her natural life, and upon the decease of the said Susan Amanda Bowen, then to pay the said principal sum of Five thousand Dollars unto such of her children and Grandchildren then living, and in such shares and proportions as she the said Susan, by her last Will, or any writing in the nature thereof, by her signed, notwithstanding any coverture, and whether covert or sole, shall direct and appoint, and for the want of such direction or appointment, then to pay the same to all the children of the said Susan then living, and the issue of any of them then dead in equal shares, so however that the issue of any such deceased child shall take if but one solely and if more than one, then equally among them, such part and share only as his or their deceased parent would have taken if living.

Eighth. I give and bequeath to my nephew Sidney W. Bowen the sum of Twenty thousand Dollars, and to my niece Ellen A. Bowen and nephew Charles L. Bowen each, the sum of Five Thousand Dollars.

Ninth. I give and bequeath to my nephew, John W. Purnell, the sum of Five Thousand Dollars.

Tenth. I give devise and bequeath all the rest, residue and remainder of my Estate, both real and personal, and wheresoever situate unto my nephew Elijah F. Bowen son of my brother Parker Bowen, his heirs, Executors, Administrators and assigns forever.

And I authorize and empower my said Executors or the survivor of them, upon the decease of my wife, or at any time during her lifetime with her consent and approbation to be signified by her becoming a party to and executing the Deed or Deeds of conveyance, by public or private sale or sales, at discretion, to sell and dispose of the whole or any part of my real estate and to grant and convey the same to the purchaser or purchasers in fee simple, without liability on the part of any purchaser to see to the application of the purchase money, and to manage and apply the proceeds of sales for the purposes of my Will as heretofore expressed and contained
