I give and devise all my estate to my executors to be by them sold as soon as may be after my decease and the proceeds used in carrying out this my will. No bonds shall be required. I appoint Clarence L. Cole of Atlantic City, N.J. and The Atlantic Safe Deposit and Trust Company executors.
