I give and devise unto my four children Somers S. Scull, Catharine Lee Joshua Scull and Elijah C. Scull all my Real Estate of whatsoever kind and wheresoever situated to them to be equally divided between them and their Personal Absolutely.

I hereby appoint Somers Scull and Elijah C. Scull sole Executors of this my last will and Testament. In witness whereof I have hereunto set hand and seal this twenty-third day of April in the year of our Lord one thousand eight hundred and ninety two 1892.
