Order For Probate.

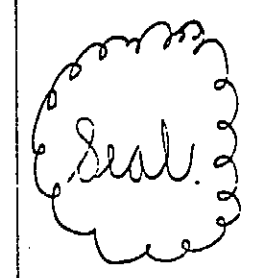
