Letters Testamentary

By the tenor of these presents, I, Charles Inwin, Register for the Probate of Wills, and Granting Letters of Administration in and for the City and County of Philadelphia, in the Commonwealth of Pennsylvania.

Do make known to all men that on the Twenty ninth day of January A.D. 1909, at Philadelphia, before me, was proved and approved the last Will and Testament of Elizabeth S. Yentler, deceased, (a true copy whereof is to these presents annexed) having, whilst she lived and at the time of her death, divers Goods, Chattels, Rights and Credits within the said Commonwealth; by reason whereof the approbation and insinuation of said last Will and Testament, and the committing administration of all, and singular the Goods, Chattels, Rights and Credits which were of the said deceased; and also the auditing the accounts, calculations and reckonings of the said administration and absolute care of the same, to me are manifestly known to belong; and that administration of all and singular the Goods, Chattels, Rights and Credits of said deceased any way concerning her last Will and Testament, is committed to George St. Story, Executor in the said Testament named; he having first been duly sworn well and truly to administer the Goods, Chattels, Rights and Credits of the deceased, and make a true and perfect inventory thereof, and exhibit the same into the Register's Office of Philadelphia, on or before the first day of March next, and to render a just and true account calculation and reckoning of the said administration, on or before the 29th day of January, one thousand nine hundred and ten (1910) or when thereunto legally required; and also diligently and faithfully regard and well and truly comply with the provisions of the Act relating to Collateral Inheritance.

In Testimony Whereof, I have hereunto set my hand and seal of Office, at Philadelphia, this 29th day of January, in the year of our Lord one thousand nine hundred and nine.

I, Elizabeth S. Yentler of 318 South 56th Street, in the City of Philadelphia, being of sound and disposing mind and memory, do make and publish this my last Will and Testament, hereby revoking and making void, all former wills by me at any times heretofore made first. I direct that my just debts and funeral expenses shall be paid as soon as conveniently may be after my decease and that

payment thereof shall be made by my executor hereinafter named out of a fund of Two hundred and fifty (\$250) Dollars payable to my estate by the Home Communion Lodge and Forty (40) Dollars payable by the Red Ladies Lodge, and I direct that Fifty-five (\$55) Dollars out of this fund shall be paid to my daughter, Mary A. Fidler, absolutely.

Item: I give and bequeath unto my executor hereinafter named the sum of Two hundred (200) Dollars to be deposited by him at the Philadelphia Saving Fund Society, and One hundred (100) Dollars of which shall be paid with the accumulations to my grandson, Herman P. Fidler, upon his attaining the age of twenty-one years and One hundred (100) Dollars of which shall be paid with the accumulations to the first child of my daughter, Harriet Story, provided that in case the said Herman P. Fidler shall die before attaining the age of twenty-one years that the amount payable to him shall be paid to his mother, absolutely and in case my daughter, Harriet Story, has no children within five years from the date of my death, or having a child or children who shall not attain the age of twenty-one years then the said One hundred (100) Dollars to be paid to the said Harriet Story, absolutely, upon the death of any such child or children.

Item: I give and bequeath unto my Executor hereinafter named the sum of Three hundred (\$300) Dollars to be deposited by him in whatever bank shall seem proper and the income or principal thereof to be used by him for the maintenance and support of my cemetery lot at Pleasantville, New Jersey, or for such other purpose as he shall deem proper in accordance with the verbal instructions, which I have given him.

Item: I give and bequeath to my husband, Edward S. Yentler, the fund of Two hundred and fifty (\$250) Dollars or whatever sum it may be now on deposit in the Second National Saving Fund at Atlantic City, and the fund of One hundred (100) Dollars payable to my estate by the Shepherd of Bethlehem Lodge and One hundred (100) Dollars in the Columbia Investment and Realty Company, provided he keeps up the payments thereon, absolutely.

Item: I give and bequeath unto my grandson, Herman P. Fidler, my lot at Pleasantville, New Jersey, absolutely and in fee simple.

Item: Out of my household goods I give and bequeath unto my daughter, Mary A. Fidler, my sewing machine, oak chiffonier, oak bureau, one oak bed room chair, and my dining room furniture; to my daughter, Harriet Story I give my oak wardrobe, oak bureau, bedstead, one bed room chair and china closet.

Item: It is my desire that my daughters shall each take back any china or cut glass they may have given to me at any time and divide the remainder equally between them.

Item: I desire that my cooking utensils shall be equally divided between my two daughters.

Item: I give and bequeath my parlor suite, and parlor rug to my daughter, Mary A. Fidler, and I desire that my table linen, bed linen and all the remainder of my furniture shall be
