I do give and bequeath unto my nephew Char. M. Shoemaker thirty shares of the stock of the Girard Fire and Marine Insurance Co. - And I direct my Executors to transfer said stock of Girard Fire and Marine Insurance Co. as soon as practicable after my decease. I further direct my Executors to sell or change any of my securities not already disposed of as they may see proper.

I do give and bequeath to Marie M. Wilson the sum of Five Hundred dollars

I do give and bequeath unto Susan Y. Wilson the sum of Five Hundred dollars

I do give and bequeath unto Elias Y. Wilson Five Hundred dollars

I do give and bequeath unto Susan Y. Wilson of Char. M. Shoemaker the sum of Five Hundred dollars

I do give and bequeath unto Samuel P. Shoemaker the sum of Five Hundred dollars (Elias Yokes Jr.)

I do give and bequeath unto Hannah Wilson sister of my wife the sum of Two Thousand (\$2000) dollars

Note that in the event of the death of C. Harry Shoemaker before my own decease then it is my will and do direct that said twenty shares of Girard Fire and Marine Insurance Co. stock to become a part of my residuary estate.

And all the rest Residue and remainder of my Estate Real and Personal whatsoever and wheresoever I give devise and bequeath unto my dear beloved wife Susan B. Yokes her heirs and assigns forever, and I do hereby nominate and appoint my said wife Susan B. Yokes nephew Charles M. Shoemaker and Jacob Duffield son of Thomas Duffield Executors of this my last will and Testament.
