

7. If you answer the sixth interrogatory in the affirmative, did said Alfred Warriner then request you and said Samuel G. Bush to sign said paper writing as witnesses and did you then sign said paper writing in the presence of said Alfred Warriner and of each other?

Deposition of witness Produced, Sworn and Executed the 5th day of September, nineteen hundred and sixteen, under and by virtue of a Commission issued out of the Surrogate's Court of the County of Atlantic in the State of New Jersey, in the Matter of the Probate of the Last Will and Testament of Alfred Warriner, deceased, therein depending:

John B. Warren, of the City of Houston, in the County of Harris and State of Texas, a witness produced on the part of the proponent, being duly sworn deposes and says:

First to the first interrogatory he says Yes, I was acquainted with Alfred Warriner but I did not know his residence.

Second. To the second interrogatory he says Yes, I recognize my signature attached to the last will and testament of the said Alfred Warriner, I signed it as a witness.

Third. To the third interrogatory he says Alfred Warriner was present when I signed this will as a witness, and I signed it at his request. I do not remember whether anybody else was present at the time that I witnessed this will, as it has been several years ago.

Fourth. To the fourth interrogatory he says I have examined the signature of Alfred Warriner attached to this will, I saw him sign this will in my office.

Fifth. To the fifth, interrogatory he says Yes, I was present when Alfred Warriner signed this will. I do not remember who else was present, but presume that the other subscribing witness, Samuel G. Bush, was present. I signed the said will as a witness in my office in Houston, Harris County, Texas, and saw Alfred Warriner sign the same.

Sixth. To the sixth interrogatory he says Yes, Alfred Warriner, at the time of signing the said will, sealed, published, pronounced and declared the said will to be his last will and testament in my presence, and I believe in the presence of Samuel G. Bush, the other subscribing witness, though I have no definite recollection as to whether Samuel G. Bush, was present or not.

Seventh To the seventh interrogatory he says Yes On the date of this will, to-wit Feb., 5, 1909, Alfred Warriner came to my office and asked me if the will was a good one, and I told him yes, when he signed it and it was witnessed by two witnesses. He told me the will was in his own handwriting and that he had written it himself. Samuel G. Bush must have been present at that time, or later, when I signed this will as a witness.
